MINUTES of the COUNTRY CLUB HOA BOARD MEETING - 14 December 2021

The December Board Meeting was canceled due to the holiday season and lack of urgent business. The financial reports were approved by all board members via email.

FINANCIAL REPORT:

- a. The Treasurer's Financial Reports for the period ending 30 November 2021 are provided in Attachments 1-3.
- b. The HOA has \$10,459.22 available for its use with an operating balance of \$8,098.42 and a reserve account balance of \$2,360.22.
- c. The November 2021 US Bank statement reconciled without issues. The operating checking account balance is currently \$24,555.49 with \$15,892.53 reserved for Waste Connections (WC) and another \$564.54 reserved for the History Fund.
- d. In mid-November, Ken and Marty worked together to bill all 167 existing WC trash service customers. Some bills were sent via email, and some were paper invoices sent via USPS. Heidi Spellman did the folding, stuffing, stamping of the invoices as well as taking them to the Post Office. As of this report we've received payments from 100 existing customers with 67 still due. They expect these remaining customers to respond to the billings before Christmas. Our first monthly 2022 CCHOA trash service payment is due on 1 January 2022.
- e. CCHOA residents who don't use the HOA trash service will be sent voluntary invoices for our \$30 annual dues in January 2022.
